### PAYMENTS

**Full payment is required 5 days before the Group/Charter date.**

#### *Cancellations & surcharges:*

In cases of cancellation, the 20% deposit that has been paid is non-refundable, except for weather or mechanical issues.

#### *Weather, safety & equipment:*

The charter will proceed in all weather except tropical typhoon signal 3 and black rain (and higher).

If a tropical typhoon signal of three or higher or the black rainstorm warning is hoisted at 7:00 a.m. on the day of sailing, all trips on that day will be postponed and rescheduled or a refund instead, the company will refund 50% of the fee.

If during the charter, tropical typhoon signal 3 is hoisted, the Captain reserves the right to return to the pier early as per the marine ordinances for safety reasons. No compensation will be made for the remaining time unused.

If a mechanical fault occurs before the boat starts its journey and repair cannot be made on time, the company will inform the charterer as soon as possible and offer a full refund.

If the boat malfunctions during the trip, we will return passengers to land. If the boat spends more than half of the time fishing, no compensation will be given during the charter.

Onboard safety is paramount to us – we reserve the right to return the boat to the pier following dangerous or reckless behaviour onboard.

While we try to facilitate our customers, sometimes we must postpone or cancel bookings due to unpredicted weather, equipment failure or unforeseen circumstances. In such a situation, TAILCHASERS reserves the right to amend or reschedule the event.

**PLEASE NOTE: cancelling is 100% the skipper's call. He will make the best decision for the situation on the day. If you decide the weather is unsuitable and you don't come, there will be no refund unless you give us 48 hours notice.**

If we decide to cancel an event, we will reschedule according to passengers' preferences. We will contact you via your mobile, SMS, and/or email.

If a booking is postponed within 48 hours of sailing, a 20% fee will be charged to cover the costs incurred.

### PERSONAL PROPERTY

Passengers are responsible for themselves and their personal property. If property is lost on the boat, the company will not be held responsible.

#### DISCLAIMER

Tailchasers shall not be held liable for death, personal injury, loss or damage to property, howsoever arising. By signing the form and boarding the boat, you agree to the terms and conditions.

### MEDICAL

The passenger agrees to advise the Tailchasers in writing of any medical disability or illness that may adversely affect their ability to participate in the fishing they have chosen. It shall be at the discretion of the Company to refuse to accept a passenger booking where there is an unacceptable risk to the party and the Company in doing so.

#### CHILDREN

The minimum age for children onboard all sailing charters is **eight years old.**

#### WEATHER CONDITIONS

Whilst the captain will make every effort to give the passengers maximum time on the sea, weather conditions may be such that, in the opinion of the Captain, the boat or crew may be in danger, and in such circumstances, the vessel will remain in a place of safety.
